INTERNET BANKING CUSTOMER AGREEMENT

With regard to use of **fNBCAMBRIDGE** Internet Banking Services ("Service"), the undersigned customer agrees to the following:

1. By using this Service, customer agrees to be bound by all rules and regulations applicable to customer's deposit account as established and amended by The First National Bank.
2. Fees for this Service shall be payable in accordance with a schedule of charges as established, and amended, by The First National Bank from time to time. These disclosures are available online at www.fNBCAMBRIDGE.com
3. Collected funds must be available for distribution from Customer's account as of the close of the business day on the scheduled payment date. Approximately five business days should be allowed for payments to be received and posted by the payee.
4. The First National Bank is not responsible for: a) errors in amounts, payee information or payment dates entered by customer; b) errors in addresses, account numbers or other information provided to the Bank by customer; c) late fees or other similar charges imposed by payees and incurred by customer; d) consequential or incidental damages for negligent performance by Bank of its services; e) damages arising from unauthorized access to **fNBCAMBRIDGE** online services.
5. Unless otherwise noted, the meaning of terms as used by this agreement and in information incorporated herein shall be as defined by the applicable provisions of the Nebraska Uniform Commercial Code.
6. The laws of the State of Nebraska shall govern this agreement and all transactions hereunder. Customer acknowledges that he/she has reviewed this Customer Agreement, understands the terms and conditions herein, and agrees to be bound hereby.
7. We are restricted from making alimony payments, child support payments, tax payments, or any court-directed or government payment, fine or penalty.

PERSONAL IDENTIFICATION NUMBER (PIN)
